Data Collected in a Non-Automatic Way

This data may be collected using the following methods:

How We Use Personal Data

Data collected on our Site will only be used for the purposes specified in this Privacy Policy or indicated on the relevant pages of our Site. We will not use your data beyond what we disclose in this Privacy Policy.

The data we collect when the user performs certain functions may be used for the following purposes:

1. For comparison to other boats within and without our geographic jurisdiction for determination of relative speed potential.

Who We Share Personal Data With

Officers/Employees/Contractors

We may disclose user data to any member of our organization or individuals employed by our organization who reasonably needs access to user data to achieve the purposes set out in this Privacy Policy.

Third Parties

We may share user data with the following third parties:

1. Members Contractors employed by our organization and public in general.

We may share the following user data with third parties:

1. Reported or imputed dimensions and owner supplied data contained on handicap certificates published.

We may share user data with third parties for the following purposes:

1. Determination of relative speed potential of sailboats and administrative necessities of our organization.

Third parties will not be able to access user data beyond what is reasonably necessary to achieve the given purpose.

Other Disclosures

We will not sell or share your data with other third parties, except in the following cases:

- 1. If the law requires it;
- 2. If it is required for any legal proceeding;
- 3. To prove or protect our legal rights; and
- 4. To similar speed potential organizations in the event that we seek to merge any functions/operations of our organization with like minded organizations.

How Long We Store Personal Data

User data will be stored until the purpose the data was collected for has been achieved...

How We Protect Your Personal Data

In order to protect your security, we use the strongest available browser encryption and store all of our non-public data on servers in secure facilities. Non-public data is accessible only to our officers. Our Officers are bound by confidentiality agreements and a breach of this agreement would result in the termination of access to the browser.

While we take all reasonable precautions to ensure that user data is secure and that users are protected, there always remains the risk of harm. The Internet as a whole can be insecure at times and therefore we are unable to guarantee the security of user data beyond what is reasonably practical to our organization.
